By my signature, I further represent that I am a competent adult and as such, I hereby release and agree to hold harmless, defend and indemnify the Molalla Rifle Club, its officers and agents from and against any and all actions, causes of action, claims, demands, damages or costs of any nature, arising out of, or in any way connected with my use of the Molalla Rifle Club firing ranges, even if resulting injuries or damages are due to negligence on the part of the Molalla Rifle Club, its officers or agents. I make this release on behalf of myself, my spouse/partner, my heirs, executors, administrators and assigns, and it extends to all claims of any nature whatsoever, whether brought on behalf of me, my heirs, executors, administrators, assigns or third parties. I understand and agree that this Release of Liability and All Claims is intended to be as broad and inclusive as permitted by Oregon law, and that if any part of it is held invalid, it is agreed that the balance, notwithstanding, shall continue in full force and effect. I declare and represent that in making this release, I have relied wholly on my own judgment and that I have not been advised or influenced to any extent whatsoever by the Molalla Rifle Club, its officers or agents.

Finally, by my signature, I attest to the following: I am not a fugitive from justice nor am I an illegal user of, or addicted to marijuana, any narcotic or other controlled substance. I have never been convicted in any court of a crime punishable by imprisonment for a term exceeding one year, even if I was given a shorter sentence. I have never been adjudicated as mentally deficient or committed to a mental institution. I have never been convicted in any court of a misdemeanor crime of domestic violence and am not currently subject to any court order restraining me from harassing, stalking or threatening an intimate partner or child of such partner.
